A DECLARATION

BY THE REPRESENTATIVES OF THE
UNITED STATES OF AMERICA,
IN GENERAL CONGRESS ASSEMBLED.

WHEN in the Course of human Events, it becomes necessary for one People to dissolve the Political Bands which have connected them with another, and to assume among the Powers of the Earth, the separate and equal Station to which the Laws of Nature and of Nature's God entitle them, a decent Respect to the Opinions of Mankind requires that they should declare the causes which impel them to the Separation.

We hold these Truths to be self-evident, that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the Pursuit of Happiness--That to secure these Rights, Governments are instituted among Men, deriving their just Powers from the Consent of the Governed, that whenever any Form of Government becomes destructive of these Ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its Foundation on such Principles, and organizing its Powers in such Form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient Causes; and accordingly all Experience hath shewn, that Mankind are more disposed to suffer, while Evils are sufferable, than to right themselves by abolishing the Forms to which they are accustomed. But when a long Train of Abuses and Usurpations, pursuing invariably the same Object, evinces a Design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future Security. Such has been the patient Sufferance of these Colonies; and such is now the Necessity which constrains them to alter their former Systems of Government. The History of the present King of Great-Britain is a History of repeated Injuries and Usurpations, all having in direct Object the Establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid World.

- He has refused his Assent to Laws, the most wholesome and necessary for the public Good.
- He has forbidden his Governors to pass Laws of immediate and pressing Importance, unless suspended in their Operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them.
- He has refused to pass other Laws for the Accommodation of large Districts of People, unless those People would relinquish the Right of Representation in the Legislature, a Right inestimable to them, and formidable to Tyrants only.
- He has called together Legislative Bodies at Places unusual, uncomfortable, and distant from the Depository of their public Records, for the sole Purpose of fatiguing them into Compliance with his Measures.
- He has dissolved Representative Houses repeatedly, for opposing with manly Firmness his Invasions on the Rights of the People.
- He has refused for a long Time, after such Dissolutions, to cause others to be elected; whereby the Legislative Powers, incapable of Annihilation, have returned to the People at large for their exercise; the State remaining in the mean time exposed to all the Dangers of Invasion from without, and Convulsions within.
- He has endeavoured to prevent the Population of these States; for that Purpose obstructing the Laws for Naturalization of Foreigners; refusing to pass others to encourage their Migrations hither, and raising the Conditions of new Appropriations of Lands.
- He has obstructed the Administration of Justice, by refusing his Assent to Laws for establishing Judiciary Powers.
- He has made Judges dependent on his Will alone, for the Tenure of their Offices, and the Amount and Payment of their Salaries.
- He has erected a Multitude of new Offices, and sent hither Swarms of Officers to harass our People, and eat out their Substance.
- He has kept among us, in Times of Peace, Standing Armies, without the consent of our Legislatures.
- He has affected to render the Military independent of and superior to the Civil Power.
- He has combined with others to subject us to a Jurisdiction foreign to our Constitution, and unacknowledged by our Laws; giving his Assent to their Acts of pretended Legislation:
 - For quartering large Bodies of Armed Troops among us:
 - For protecting them, by a mock Trial, from Punishment for any Murders which they should commit on the Inhabitants of these States:
 - For cutting off our Trade with all Parts of the World:
 - For imposing Taxes on us without our Consent:
 - For depriving us, in many Cases, of the Benefits of Trial by Jury:
 - For transporting us beyond Seas to be tried for pretended Offences:
 - For abolishing the free System of English Laws in a neighbouring Province, establishing therein an arbitrary Government, and enlarging its Boundaries, so as to render it at once an Example and fit Instrument for introducing the same absolute Rule into these Colonies:
 - For taking away our Charters, abolishing our most valuable Laws, and altering fundamentally the Forms of our Governments:
 - For suspending our own Legislatures, and declaring themselves invested with Power to legislate for us in all Cases whatsoever.
- He has abdicated Government here, by declaring us out of his Protection and waging War against us.
- He has plundered our Seas, ravaged our Coasts, burnt our Towns, and destroyed the Lives of our People.
- He has plundered our Seas, ravaged our Coasts, burnt our Towns, and destroyed the Lives of our People.
- He is, at this Time, transporting large Armies of foreign Mercenaries to compleat the Works of Death, Desolation, and Tyranny, already begun with circumstances of Cruelty and Perfidy, scarcely paralleled in the most barbarous Ages, and totally unworthy the Head of a civilized Nation.
- He has constrained our fellow Citizens taken Captive on the high Seas to bear Arms against their Country, to become the Executioners of their Friends and

The Second Declaration of Independence Referendum One

Referendum to be voted on by the General public, the state legislators and senators in the legislature, by the town and city councils, by the county commissioners, and to then be voted on by legislature to declare Independence from a illegitimate Federal government plagued by criminals and power usurpations.

TO BE SUBMITTED TO THE STATE LEGISLATURES AND IT'S PEOPLE WHICH INCLUDES REGISTERED VOTERS FOR CONSIDERATION, FEB 28TH, 2013,

The unanimous Declaration of the citizens and of the legislatures of the fifty United States of America,

(Reciting from the 1776 American Declaration of Independence)When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. We have witnessed a government that is out of control, refusing to enforce and use their powers under the rule of law, has committed war crimes and atrocities, has threatened and harassed the state legislatures, has become deaf to the wishes of the American people and their unalienable Rights, has used foreign military recruits to get ready to harass the people, has implemented or used terrorist attacks in order to dictate the people to their submission, has been using a private banking institution to devalue the dollar and to wreck the people and rob them of their possessions and property, and are seeking to convert the United States of America into a Military Police State run by a bureaucratic and unaccountable elite of politicians.

Crimes are being committed by the Office of President, some of the members of Congress due to threats and blackmail, and even the Judicial branch has fallen into judicial activism where judges no longer rule behind the facts and the law but rule under the whim of the tyrannical government. People across the country are being unfairly convicted then imprisoned not because of law or because of what action being done is harmful to another, but that people are being convicted in mass for victimless crimes and in many cases the perpetrator was innocent, but the court wanted more people in prison so they ruled the innocent to be guilty for more money and benefiting the judicial and police community. In other cases what people do in their own homes, on their own properties is becoming criminal, that computer devices are also being used as a spy machine to throw people in prison as well for victimless crimes including for the supposed crimes of sharing knowledge.

While many Americans are more disposed to suffer, while evils are sufferable, than to right

themselves by abolishing the forms to which they are accustomed. But when a long train of abuses of power and usurpations of power, pursuing invariably the same Objective and Agenda evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.

The history of the present Executive Branch of the United States, some of the members of Congress, and the Justices in the judicial branch all have a history of repeated injuries and usurpations, all having in direct objective which is the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world.

Executive Branch tyrannies – Information cited from Alexander Emerick Jones from Austin Texas the Articles of Impeachment filed in the Court of Public Opinion.

- He has aided America's enemies, violating his oath, by sending funds to insurgents in Syria who are [being commanded by Al-Qaeda terrorists](#).
- He has violated federal law by [overseeing a cover-up surrounding Operation Fast and Furious](#), the transfer of guns to Mexican drug cartels direct from the federal government.
- He has lied to the American people by overseeing a cover-up of the Benghazi attack which directly led to the deaths of four American citizens. [The cover-up has been called "Obama's Watergate."](#) yet four months after the incident, no one in the administration has been held accountable.
- He has brazenly undermined the power of Congress by insisting his authority came from the United Nations Security Council prior to the attack on Libya and that Congressional approval was not necessary. "I don't even have to get to the Constitutional question," [said Obama](#). This is an act that "constitutes an impeachable high crime and misdemeanor under article II, section 4 of the Constitution," [according to Congressman Walter Jones](#).
- He has [flagrantly violated](#) article 1, section 9, clause 8 of the Constitution by accepting rotating status as chairman of the United Nations Security Council. The clause states, "No title of nobility shall be granted by the United States; and no person holding any office of profit or trust under them, shall without consent of Congress accept of any present, emolument, office, or title, of any kind whatever, from any King, Prince, or foreign State."
- He has ignored Congressional rejection of the cybersecurity bill and instead indicated he will pursue an [unconstitutional executive order](#).
- He has signed into law the National Defense Authorization Act which includes provisions that permit the abduction and military detention without trial of U.S. citizens, violating Habeas Corpus. Despite Obama claiming he would not use the provisions to incarcerate U.S. citizens, it was his administration that [specifically demanded](#) these powers be included in the final NDAA bill.
- He has enacted universal health care mandates that force Americans to buy health insurance, [a clear violation of the Constitution](#) in exceeding congressional power to regulate interstate commerce. Obama has also handed out [preferential waivers to corporations](#) friendly to his administration.
- He has declared war on America's coal industry by [promising to bankrupt any company](#) that attempts to build a new coal plant while using [unconstitutional EPA regulations](#) to strangle competition, ensuring Americans see their energy costs rise year after year.
- He has violated the Constitution's Takings and Due Process Clauses when he [bullied the secured creditors of automaker Chrysler](#) into accepting 30 cents on the dollar while politically connected labor unions and preferential others received better deals.

- He has violated Article II of the Constitution by [using signing statements](#) as part of his executive usurpation of power.

For these, and other offenses which constitute **high crimes and misdemeanors**, including **perjury of oath, abuse of authority, bribery, intimidation, misuse of assets, failure to supervise, dereliction of duty, conduct unbecoming** and **refusal to obey a lawful order**, we call for the immediate impeachment of Barack H. Obama.

Executive Branch tyrannies

- In November 2012, many people petitioned the President of the United States to peacefully allow their states to leave the union without the threat of F16's and military airstrikes and military invasions of states that attempt to leave the union. The president denied those petitions and said that states do not have a right to leave the union. What the president has done was declare that the states are to be held hostage to the Federal union that is abusing its power with no hope of intervention or remedy to stop the long trail of abuses and usurpations that is pursuit to the same objective which is to reduce the quality of life, the liberties of the individual and to force the general people into a public collectivism, take away their property and right to pursue happiness, and to reduce the common people into an absolute despotism. The states created the Federal government not to abolish the states but to keep a check on the states and the states to keep a check on the Federal. The Constitution does not have any clause which states that a state cannot leave the union. Once a state legislature with approval from the governor or by a supermajority of the legislature petitions to leave the union by its governing authority a state is no longer under Federal law nor should they have to follow any federal order. That state would no longer be apart of the union. The civil war in America does not change the fact nor in the Constitution that a state can leave the union by simply declaring Independence from that union especially from a illegitimate government that is trampling over the natural rights of the people.

Legislative Branch tyrannies

- Some of the members of Congress have committed insider trading which is already a criminal offense which may constitute being thrown out of office yet the members of Congress passed a law against insider trading when in reality it was already illegal then used it as a loophole to allow them to get by with the future violations of insider trading, a deceitful action.
- A majority of the Congress which includes both the House of Representatives and the Senate has knowingly passed the National Defense Authorization Act for fiscal year 2012 and 2013 law, even one of the Amendments resorted to legal trickery which would re-enable the NDAA 2012 law in 2013 version. They knowingly passed a law that takes away the protections in portion of the entire Constitution and state Constitutions thus illegally seizing lawful power from the states and the Federal criminal justice system to forcefully detain American citizens and lawful residents in a secret prison without the right to a trial by jury, the right to a speedy trial, the right to question witnesses, the right to a lawyer, the right to an appeal to a higher court, and the right to petition for habeas corpus that is engraved in both the state and federal

constitutions.

- The Congress keeps passing more and more laws taking away the powers of the states and the authority of the states turning the states into nothing more than labeled territories under Federal control even though the Federal form of governance was only created for interstate affairs of commerce and on matters that the states cannot handle themselves. The Federal Government was created by the power given by the states and that the Constitution does not grant the abolition of state power nor does it invoke its tyrannies upon the states to which the majority of people disagree and are disposed to suffer. Now the Federal government holds power over agriculture, electricity, commerce, health, freedom, liberty, rights, and even the personal decisions of the people within the states, that it is no longer regulation of interstate commerce and interstate matters but that the Federal government is issuing laws controlling the people in every state to which has been apart of the union.
- The Federal government is trampling over the natural rights of mankind. Those natural rights include gardening, protecting the family from predators and psychopaths, that sexual orientation remain the right of the individual not decided by the state nor any union, health choices made by the doctor or the patient and that health be a free choice of each informed person, the right to make and use herbs, the right to make a baby without restrictions on overpopulation, the right to speak freely on the individuals concerns of the government, the right to petition for a redress of grievances, the right to form a well regulated militia to preserve the free state and that the right to keep and bear arms shall not be infringed, the right to peaceful assembly whether it be protesting or holding a private political meeting talking about how they can organize to fight the corruption or any wrongs in their government, the right to freedom of expression, and that government shall not force any individual to join a religion or have anything to do with a religion as that right belongs respectively to the people. There are more rights this declaration did not cover but let's leave that decision to the people themselves that have been usurped and injured by the government.
- The members of Congress are starting to illegally transfer their powers over to the executive office and the President. Because of that they traitorously violated their Oaths by transferring over their duties and responsibilities over the office of the President. The president is now signing Executive Orders as if they were laws the president was making and enacting. It is the Congresses duty to assert their powers of lawmaking against the executive branch by ordering the president to stop making his own version of executive laws and that executive orders are only permitted to the extent prescribed by Congress and by law. The Executive branch cannot take actions outside of law since that would make the Legislative and Judicial branches obsolete as if they don't exist anymore which is dangerous to the public. The fact that Congress has been blackmailed, committing crimes, being threatened, being coerced, bribed by lobbyists, and the fact that their districts are too large has made Congress less sympathetic to the issues and has instead committed acts of high treason by knowingly allowing the President to become a higher power until Congress is obsolete and the abolition of the states is inevitable.
- Congress has passed laws that begin sucking away the powers of the legislatures.
- The States have been victimized by Federal drug laws. When several states attempted to allow use of marijuana only for medical usage approved by a doctor or medical professional, the Federal government has raided and terrorized the state and its people saying the Federal government is supreme and that people will go to prison for a very long time for obeying state laws. Another Congressional abuse of power against the individuals and the states.

Judicial Branch tyrannies

- The Supreme Court has ruled that strip searches including cavity searches and sticking their hands down the rear ends of individuals physically raping people and molesting them would be permitted even for unpaid parking tickets, fines, throwing out cigarettes and littering, and other non-violent acts that are considered criminal are being used as an excuse to touch peoples genitals when there is not evidence that they are a threat to themselves or others and that they have not done anything to hide any contraband in such areas.
- The appeals court ruled that the injunction on the NDAA law that violates the Constitution be thrown out and that the NDAA is allowed to be used against citizens.
- The activist judges in all Federal courts have made rulings to take away the rights of the general people including farmers and ranchers.
- A federal court ruled that Jesse Ventura does not have jurisdiction to sue the TSA for blatant violations of law and the Constitution. He could appeal it but would not have the right to a trial by jury even though both the US and state Constitutions give people the right to a trial by jury whether it is a civil or criminal offense.
- The Supreme Court, the appeals courts, and even the lower federal courts have made rulings that are in itself questionable for people in the judicial community and in studies and practices of law.

It is clear that criminal activities have plagued the highest levels of Government whether it be the CIA, FBI, DHS, ATF, and any other government department, agency, or even in the three branches of government that authorized the agencies.

We whom sign the Second Declaration of Independence Referendum One feel that the government is out of control whether it is democrats or republicans, it doesn't matter who is at fault at this point except to say the entire government needs to be reformed. We the Declaration signers feel that the government needs to be held accountable and that a major overhaul in the Federal system of government is the answer to societies problems.

We feel there needs to be a reform in

1. The Executive Branch.
2. The Legislative Branch.
3. The Judicial Branch.
4. The Food and Drug Administration and the Drug Enforcement Agency.
5. The election process including the electoral colleges to prevent election fraud.
6. State Governments that have blindly turned over to Federal corruption and have gone against the liberties of their people.
7. Local governments that have evidence of usurpations against their people and corruption.
8. The police departments found and known to be corrupt.
9. The Sheriffs offices found and known to be corrupt.
10. The fire departments that are found and known to be corrupt. That includes fire fighters spying on and targeting political dissidents over what the DHS and any other agency is deceitfully telling them.
11. The Department of Homeland Security.
12. The Federal Bureau of Investigation.
13. The Central Intelligence Agency.

14. The Health Department.
15. The department of Social Services including the Child Protective Service. The states can still have a social services department just not the Federal government.
16. And reforms in any other agencies and functions of government.

We the people and upon approval from each of the state legislatures, we humbly declare that we wish to dismantle the Federal Government and reconstitute the republic, that we bring in a new Congress, a new Executive office, and a new Judicial branch with a few modifications and one of them is the right of the people to elect their Justices in the Supreme Court to prevent executive corruption in the courts, and that the states handle most of the issues in modern society including that of helping the elderly and disabled including combat veterans with missing limbs and have PTSD. We believe the states should be the government entity to provide programs to help the disabled and veterans out there in their respective states instead of the Federal government as they could threaten to cut off the programs to disabled people that are involved in any way politically which is injurious to the well being of the people that are disabled although some will disagree but it is better for states to have a safety-net than the Federal government. The states are more closer to the people and is more easily accessible to the people while the Federal government is a whole lot farther from their Constituents. The states should make laws over certain issues instead of a Federal government as states have suffered over Federal laws since they apply to all states even if representatives from certain states disagree, Federal law applies to all states even in states that disagree with them which is damaging to those states which was partially why the Confederate States of America was formed but was on the wrong path when they Constituted slavery in their Constitution. Slavery is wrong no matter what race, gender, religious belief, or even political ideologies someone has.

The purpose of this declaration is to first separate states from the union, then form a new Federal Government with a new Constitution that will provide better safeguards in government for our future security. This new Constitution will constitute a new Congress, a new Executive Branch, and a new Judicial Branch that will nullify any future efforts to corrupt the government and to usurp powers away from the states and from the people. There are cases when a Federal government is needed in cases of state corruption and abuse of power in a state or even local towns and cities where those powers imprison and enslave we the people. There are some cases where the Federal government is too powerful over the states and have injured many people for their beliefs, their personal decisions that do not injure other parties (common law), and start to dictate what people will go to prison for and what they are not until people have become robots as it doesn't matter what is right from wrong anymore because the law dictates the lives of the people which is a abuse of their natural god given rights.

The purpose of this declaration, in simple terms, is to reconstitute the republic, not to turn states into Independent countries, but to recreate the Union to which the states are unified under the Almighty god or intelligent creator of the universe. The Federal government will keep a watch on state power and yet the states will keep a watch on Federal power, there shall be more states rights than before where a state will have the right to nullify a law that would injure the citizens of a particular state, and allow self responsibility and integrity to be kept to the individual and not to a supreme authority over the lives of their subjects.

We feel the current Federal government is doomed to fail and will destroy the lives of a majority of the people and thrown them into a hell of a society where deceit and suffering becomes the norm of society across the United States.

Therefore we as statesmen, as citizens, and we as the injured, wish to use the Tenth Amendment under the U.S. Constitution Bill of Rights, and the first American Declaration of Independence to leave the union, declaring no confidence in our Federal governing system, and vote on reconstituting the new Continental Congress, a new republic, and debate how this new system will be formed. There shall be a new Constitutional Convention not by the corruption in Congress but by the states that implemented

the first Federal government. We the states and citizens have had enough of putting up with corruption, abuse, suffering, and damage done by a unaccountable government.

We declare Independence from the United States to Constitute a new Federal Government and union to which the states will belong to.

This referendum will use the Tenth Amendment of the U.S. Constitution and the Declaration of Independence as it's legal standing for the actions taken under this referendum. The signing of this declaration will be valid among signatures from the majority of registered voters in each district of their state, then each district shall send this referendum to their legislators and senators representing their district as the Constituents have voted no confidence in the Federal system of government, then the legislators will introduce as a bill into their respective General Assembly then upon voting by a majority of members in both houses and committees as their State Constitutions have stated or whatever process has been stated in their legislature, then approved by the governor or by a super-majority in the event where the governor vetoes this referendum as a resolution. We the signers have lost confidence in the Federal government and demand that a new republic be created to unionize the states as before in 1776 when America was first created. We hereby sign this referendum as registered voters, as statesmen, as free and equal human beings, and as people to restore the republic and lawfully reset the Federal government or create a new Federal government that will obsolete the old tyrannical system. The U.S. Constitution doesn't prohibit states leaving the union therefore the Federal government has no authority to force states to remain with the union. The states have a right to leave the union then create a new Federal government with a new Federal administration not plagued by election fraud and intimidation. Disclaimer and Notice: Of course this document can be modified to list more crimes or even reference where anybody can lookup the crimes committed by the executive, judicial, and legislative branch. It is not set in stone nor is this a bill but this document creates a declaration that can be signed by members of the General Assembly of the state legislature, the mayors and town and city council members, the county commissioners, and even by Congressmen if they believe this will better help the country. This document is a template and legal declaration and once it fully lists the crimes done by government and even assassinations against political activists like Martin Luther King Jr., Andrew Breitbart, and Aaron Swartz (**democide** is death by government), then it can and will be signed by each person. Nobody has to sign a petition at Whitehouse.gov or any website that can track and trace people yet have no real benefit. Legislators rather have real signatures to declare Independence for the state. The purpose of this document is not to secede from the union but to secede only to reconstitute the republic, create a new liberty minded republic that will not trample upon the natural rights of the individual and will not convert public servants into officials. This declaration is not subversion and not sedition in nature but is about declaring the peoples natural rights that have been taken by the corrupt criminalized government. Those rights shall not be infringed and that with this declaration the people can finally bring back a representative form of government with high confidence in the political system and in the voting system without fear of election fraud and persecutions. February 28th 2012 is the date for when it is assumed enough time has passed for voting on this referendum and that it be presented to the state legislatures. Please sign your full name so that the state can confirm that you as a registered voter as they have more power in the dealings with the state then somebody whom has not voted. This document is not meant to aid, abet, nor protect criminal conduct. This document is only to protect the natural rights of the people and to declare no confidence in the Federal system.
